- 1. I am admitted to practice before Courts in the Commonwealth of Pennsylvania and the State of New Jersey; the Eastern District of Pennsylvania; the Courts of Appeals for the Third, Fifth, Sixth, Seventh, Eighth, and Eleventh Circuits; the Supreme Court of the United States; and various federal district courts. I am the founder and firm manager of NastLaw LLC ("NastLaw"). I have been appointed by this Court as Co-Lead Class Counsel for the Direct Purchaser Classes ("DPPs") in this litigation, and I was actively involved in and oversaw my firm's participation in this litigation. NastLaw's firm resume is attached as Exhibit 1 hereto.
- 2. I provide this Declaration in support of Direct Purchaser Class Plaintiffs' Motion for an Award of Attorneys' Fees, Reimbursement of Costs and Expenses, and Representative Plaintiff's Service Award ("Fee Petition").
- 3. NastLaw prosecuted this case on a contingent-fee basis with no guarantee of recovery.
- 4. NastLaw's involvement in this case was extensive. As Co-Lead Counsel, I participated in multiple meetings and strategy sessions, including discussions related to case strategy, the engagement of experts, research projects, pleadings, and responses to pleadings. When called upon to suggest candidates as potential expert witnesses and mediators, I suggested several candidates.
- 5. Additionally, I or another NastLaw attorney in my absence attended all status conferences with the Honorable Edward M. Chen either in-person or via Zoom.
- 6. From the beginning of this case to settlement, NastLaw attorneys willingly and professionally responded to every assigned task. I worked closely with NastLaw attorneys on these tasks to help move the litigation forward. If scheduling conflicts arose, making me unable to assist with these tasks, Daniel N. Gallucci stepped in to help.
- 7. In addition to myself and Mr. Gallucci, NastLaw attorneys Michele S. Burkholder, Michael S. Tarringer, Joanne E. Matusko, and Joseph N. Roda have been directly involved in all facets of this litigation, from inception ongoing through the present.

- 8. By way of example, I and the NastLaw attorneys performed research and drafted or assisted with drafting the initial class complaint, and the amended class complaint.
- 9. Additionally, NastLaw attorneys researched and drafted motions and responses to various defense motions. By way of example, Ms. Burkholder undertook the task of researching and drafting a response to Defendants' Motions to Compel Arbitration. Mr. Tarringer presented oral argument on behalf Plaintiffs related to the Motion to Compel Arbitration and assisted with the oral argument related to the Motion to Dismiss. DPPs' were successful with their challenge to these two motions.
- 10. Also, I and the NastLaw attorneys drafted or assisted with drafting Plaintiffs' motion for class certification, Daubert motions, and motions in limine as well as drafting oppositions to these same motions filed by Defendants.
- 11. Additionally, Mr. Tarringer and Ms. Matusko represented DPP Class members for several dozen deposition witnesses including Gilead fact witnesses, Plaintiffs' and Defendants' experts, and third-party entities. Prior to each deposition, the attorney assigned to the deposition analyzed documents, identified exhibits for use during the deposition, and drafted potential questions for each deponent. At the completion of each deposition, the covering attorney drafted a summary of the testimony and circulated it to DPP co-counsel. For the depositions of Plaintiffs' experts, Mr. Tarringer and Ms. Matusko participated in deposition preparation sessions with their assigned experts prior to the experts' depositions.
- 12. NastLaw attorneys served on both pre-trial and trial committees. By way of example, Mr. Tarringer was a member of the NGR committee and Ms. Matusko served on the Economics committee. Ms. Matusko was responsible for revising the Economics committee white paper during the pendency of the case. Ms. Burkholder was assigned to work on the third-party subpoena committee, where she was responsible for drafting and serving dozens of subpoenas and participating in follow-up meet and confer sessions with counsel for the third parties. As trial approached, NastLaw attorneys served as members of committees formed to assist with the preparation of Plaintiffs' experts for testifying at trial.

13. Prior to the start of the trial, Mr. Gallucci, Ms. Burkholder, Mr. Tarringer, Ms. Matusko and Mr. Roda participated in a variety of trial related tasks including identifying deposition designations and exhibits for use at trial; analyzing and challenging Defendants' deposition designations and trial exhibits; drafting proposed jury instructions, voir dire questions and verdict slips in compliance with Northern District of California and Nineth Circuit law; researching case law in support of motions in limine; and drafting Plaintiffs' pre-trial memorandum for the Court.

- 14. Additionally, I and the NastLaw attorneys were heavily involved with drafting and editing the Memoranda of Understanding and Settlement Agreements for the BMS and Gilead settlements, plans of allocation, notice plans, and forms of notice and we continue to work closely with the claims administrator for both settlements.
- 15. From inception to October 31, 2023, NastLaw staff spent 10,798.9 hours advancing the litigation. The total lodestar for NastLaw is \$9,430,081. The summary below includes the name, position, years of experience, current hourly rate, time expended, and total lodestar of each person from my firm who worked on the litigation. The hourly rates shown are the current usual and customary rates set by NastLaw. The information in this declaration regarding the time NastLaw's attorneys and other professionals spent advancing the litigation was prepared from contemporaneous, daily time records maintained by the firm's timekeeping software.

- 18. As the summary shows, NastLaw made \$1,312,547.25 in contributions to the DPP Litigation Fund to cover shared litigation expenses, such as experts' fees and deposition costs, and contributed \$500,000 directly to the all-plaintiff-group litigation fund maintained by the EPPs. Also, NastLaw was reimbursed \$937,750 in connection with the BMS Settlement.
- 19. NastLaw was responsible for maintaining and overseeing the DPP Litigation Fund to cover certain common costs and litigation expenses incurred by DPPs in connection with the litigation.
